SEABOURN Cruise Line has unveiled new Seabourn Journeys, offering new pre-, mid-, and post-cruise extensions for its 2024 Grand Africa Voyage.

Philly cruises are back on

CRUISES are set to recommence from Philadelphia in 2026 for the first time in 15 years.

Norwegian Cruise Line's Norwegian Jewel will home port from Philadelphia from Apr 2026 to Oct 2026, offering seven-to-nineday voyages to Bermuda, where the ship will overnight.

Later in the season, Jewel will sail 10- and 11-day voyages to Canada and New England, alternating home ports between Philadelphia and Quebec City.

The cruises will call at ports like Saguenay, Charlottetown, Halifax, Bar Harbor, and Boston.

Cruises will recommenceme from Philadelphia in time for a number of marquee events, including the United States Semiguincentennial.

Philadelphia is expected to play a prominent role in the celebrations, given the city's extensive contributions to the United States' history.

The city will also host the MLB All-Star Game and the FIFA World Cup in 2026.

"We remain committed to delivering more experiences for our guests to create unforgettable memories, so they can vacation better with us," Norwegian President David Herrera said.



"We are particularly proud to partner with PhilaPort to launch cruising in the area, making it even more accessible to the US Mid-Atlantic region.

NZ cruise fee hike

A FORTHCOMING 88% spike in Customs fees charged to cruise travellers entering New Zealand from 01 Dec has been slammed by both the New Zealand Cruise Association (NZCA) and CLIA Australasia.

The New Zealand Ministry for Primary Industries is currently inviting submissions for the planned fee hike, which would see the levy charged to cruise ship arrivals jump from NZ\$11.48 to NZ\$21.54.


The impost is well beyond the NZ Government's own published cap of \$16.44 and brings with it scope to increase further with a new upper cap.

NZCA Chief Executive, Jacqui Lloyd, said the increased cost will have "disastrous consequences" for the country's cruise industry.

"It threatens to cost cruise lines visiting New Zealand an additional unbudgeted \$2 million for the 2024/2025 season," Lloyd commented.

CLIA Australasia said the levy increase may cause serious harm to local tourism at a time New Zealand is already seeing 22% reduced visitation from cruise ships.

The association said New Zealand is already one of the most expensive countries in the world for cruise operations and that it will be advocating for a more constructive process, with both itself and NZCA set to lodge submissions.

CRUISE guests should be suspicious of the amenities in their stateroom bathrooms, one US travel agent believes.

Cruise ships are very much in the business of sustainability and for many years have offered guests refillable soap, shampoo and other amenities in their bathrooms.

However, Hannah Westphal, the owner of US agency ByHannah Vacations, is urging travellers, who understandably may not want to bring their own from home, to be sceptical of what's onboard.

"I have to admit, I would never use those refillable shampoo and conditioner bottles in the shower." she told the UK's The Sun.

"It's a bit off-putting not knowing exactly what's in those dispensers."

"There's always the worry someone might have refilled them with something...and believe me, I've seen hair removal creams and God knows what else."

Despite Hannah's warning, she said if the toiletries are in a locked dispenser, those are usually okay to use.

Westphal's advice, if you can't bring your own from home, is to ask your stateroom attendant for new bottles to be delivered once you board.
